Why Screen?


• KEY STATS

- Less than 10% of child sexual abusers are criminally prosecuted
- Meaning 90%+ will have no red flags or marks in their history
- 4 out of 10 churches are not running the correct background check
- 75% of child sexual predators attend church on a regular basis
- 90% of child predators identify as religious or highly religious

SEASON OF LIMITED RESOURCES. SAFETY
NOT OPTIONAL BUT MANDATORY.

• SCREENING ASSUMPTIONS

- Applies to adults 18 years +
- Evaluation will be for staff or volunteer positions mainly in children's ministry
- A vital component of your overall safety plan

7 Components of Comprehensive Screening

1. APPLICATION*

- 100% completed
- Clear and conspicuous consent

2. BACKGROUND CHECK*

- Repeat every 1 - 3 years (per insurance provider)
- Major part of overall security plan

3. SOCIAL MEDIA CHECK

- Release should be returned with application
- Good indicator if individual should have access to kids

4. REFERENCES*

- Minimum of 2 professional and 2 personal (non-related)
- Can be a good validation of information on application
- Follow up! 70%+ are not

** Non-negotiable elements*

7 Components of Comprehensive Screening

5. FACE TO FACE INTERVIEW*

- Conducted by 2-3 trusted staff members
- Offers multi-dimensional view from different perspectives


6. MOTOR VEHICLE REPORT

- Role dependent
- Can reveal significant traffic incidents

7. WAITING PERIOD

- Role dependent
- Duration 30 days to 6 months

** Non-negotiable elements*



Background Check Provider Evaluation

- Are they PBSA Accredited?
- Provides notices & consent forms for applicants?
- Thorough knowledge of screening laws in your state?
(Illinois, California, New York, Michigan)
- What packages & information do they provide?
- Do they report on both felonies & misdemeanors?
(scope of reportable records)
- Do they reverify reportable information prior to report completion?



Background Check

UNDERSTANDING THE INFORMATION

Included:

- National vs. Statewide/County (different checks for different states)
- Additional states may hold different requirements
- National sex and violent offender registry list

Not Included:

- Federal or criminal cases in other states (multi-state or county search required)
- Fingerprinting (varies by state requirement and permissible purpose)

Integration Benefits

- **FAST** - results typically in 48 hours or less
- **EASY** - send application to Protect My Ministry with click of a button from within KidCheck
- **IMMEDIATE ACCESS** – background check automatically saved to individual in KidCheck
- Improved **DOCUMENT MANAGEMENT** and **BETTER ORGANIZATION**
